7 **Part I. Program History**

8 **A. Purpose**

9 A campus-wide Data Science Working Group (DSWG) was formed in 2016 to foster data science
10 research on the University of Delaware campus. The DSWG organized several meetings and
11 events over the course of 2017, and produced a white paper in autumn 2017. Those events, in
12 no small part, inspired this degree program. The examples presented in the events made it
13 clear that successful data science programs involve collaboration across multiple disciplines:
14 generally this means statistics, computer and information sciences, and mathematics together
15 with domain or application areas.

16 Data science is one of the fastest growing sectors in the US. According to “The QUANT CRUNCH
17 How the demand for data science skills is disrupting the job market”, there were more than
18 2,350,000 job listings for Data Science and Analytics (CSA) in 2015; and the demand for DSA
19 jobs is projected to grow by 15% over the following five years, which translates to additional
20 364,000 new job postings. From “Investing in America’s data science and analytics talent: The
21 case for action,” a BHEF/PWC report (pwc.com/us/dsa-skills), there were 58,151 ads for data
22 science and analytics jobs in the Philadelphia-Camden-Wilmington area in 2015 alone. In that
23 year, there were a similar number in Seattle, and around 70,000 in each of the Boston, Dallas
24 and Atlanta. In the larger metro areas of New York, Chicago, Los Angeles, San Francisco, and
25 Washington DC combined to have postings of about 750,000 such positions. It may be that this
26 is at the upper end for estimates for jobs, but there is little doubt that these staggering
27 numbers of positions are difficult for organizations to fill.

28

29 According to the global management consulting firm McKinsey, data-driven technologies will
30 bring an additional \$300 billion of value to the U.S. health care sector alone, and by 2020, 1.5
31 million more "data-savvy managers" will be needed to capitalize on the potential of data, “big”
32 and otherwise. (Manyika, J. et al., 2011, “Big data: The next frontier for innovation, competition, and
33 productivity.” McKinsey Global Institute, <http://www.mckinsey.com>).

34

35 The importance of data science was recognized in the "Final Report from the National Science
36 Foundation Computer and Information Science and Engineering Advisory Committee Data
37 Science Working Group" (<https://www.nsf.gov/cise/ac-data-science-report>). Their
38 recommendations include the creation of data science centers; to support the design and
39 development of data science pedagogy and curricula; and to invest in both national and
40 institutional infrastructure to support emerging Data Science research and education programs.

41

1 The proposed MS in Data Science is as a professional masters with a flexible set of core
2 requirements in statistics, mathematics and computer and information sciences with a range of
3 possible application areas. It is aimed at providing a solid background in the methods behind
4 data science so that our graduates can go out into their fields and work well with data, and be
5 better prepared for the next methods to come along to work with large and/or dynamic data
6 sets.

7
8 The proposed interdisciplinary MS in Data Science degree provides necessary training in
9 statistics, computer science, and mathematics, as well as domain (or application) knowledge to
10 be successful in the data science job market. The program will provide both the breadth of
11 training, and the flexibility to apply them in different fields. The flexibility allows for training in
12 different categories of positions in data science: data analysts (use mathematical, statistical and
13 modeling techniques to solve problems), data engineers (design, build and maintain an
14 organization’s data and analytical infrastructure) and data scientists (create sophisticated
15 analytical models to build new data sets and derive new insights from data).

16
17 Given the interdisciplinary nature of data science, the program exploits departmental and
18 college cooperation. The main requirements of the program comprise courses from three
19 departments (and colleges): the Department of Mathematical Sciences (DMS, in Arts and
20 Science), the Department of Applied Economics and Statistics (AES, in Agriculture and Natural
21 Resources) and the Department of Computer and Information Sciences (CIS, in
22 Engineering). Two courses would be required from each department, with each having a small
23 list from which to choose. The idea of this Master of Science in Data Science is to provide a
24 foundation in these three areas, with electives in these areas or, where appropriate, electives
25 from wide range of departments to give specific domain knowledge.

26

27 ***B. Current Status***

28 The program will begin admitting students for Fall 2018, and is expected to be reviewed for permanent
29 status in 2023. The degree program will initially be housed in the Department of Mathematical
30 Sciences, wherein physical files and administrative help will be located. Though this document governs
31 the rules of the program, some current information such as events, elective courses offered, and so
32 forth can be found on the program web page at www.msds.udel.edu.

33 ***C. Degree Offered***

34 The degree awarded to those who complete this program will be a Master of Science with a major in
35 Data Science (MSDS). The MSDS is awarded in one of the College of Agriculture and Natural Resources,
36 the College of Arts and Science, or the College of Engineering. The degree is also offered in
37 combination with a limited number of Bachelor degrees as a “4+1” program. In that case, the
38 background subjects are covered in the undergraduate degree (either through required or
39 elective courses), and six credits of the MSDS course work count toward the Bachelor degree as
40 described below.

Part II. Admission

A. Admission Requirements

Applicants must submit all materials directly to the University Office of Graduate and Professional Education using the online admission process before admission can be considered. Admission applications are available at: <https://grad-admission.udel.edu/apply/>

The program admission process is completed as follows: Completed applications consisting of the online application, undergraduate/graduate transcripts, three letters of recommendation, and the written statement of professional goals and values, are reviewed by the Executive Committee. A grade point average (GPA) of at least 3.00 is preferred. Applications are evaluated based on a combination of record of academic achievement, recommendations, and the applicant's statement of professional goals and values. The Executive Committee will make admission decisions and assign accepted students to faculty advisors upon matriculation.

International applicants must submit official proof of English proficiency such as TOEFL or IELTS scores. The recommended minimum TOEFL score is 100 and/or IELTS of 6.5.

B. Background Requirements

A Bachelor's degree from an accredited program is required for admission. A major in any of mathematics, applied mathematics, statistics, computer science or engineering, or a field of engineering is a good background for this program. Applicants for the combined Bachelors and MSDS degree program must complete the background requirements prior to beginning the MSDS course work (see the next section and section III.A.5 for more information). A minimal background outside of the above STEM majors should include at least one semester of

- multivariable calculus (MATH 243 or MATH 222 or equivalent),
- linear algebra (MATH 349 or equivalent),
- statistics and/or probability (MATH 350 or 450, or Math 205, or STAT 470 or STAT 471, or equivalent),

and at least two semesters of

- computer programming (data structures or CISC220 equivalent desirable).

Additional desirable courses include

- ordinary differential equations (MATH 302 or MATH 351 or equivalent),
- a first numerical analysis or methods course (MATH 353 or MATH 426 or equivalent),
- an algorithms course (CISC 320 or equivalent),

- 1 • a logic and programming course (CISC 304 or equivalent),
- 2 • and both probability and statistics courses (MATH 350 and MATH 450, or STAT 470 and
- 3 STAT 471, or equivalent).

4
5 The applicant shall apply to the MSDS program directly, and shall specify a specialty at the time
6 of application (CIS, AES or DMS). The executive committee makes a decision on the application
7 for this degree. If needed, the executive committee will consult with the specialty department
8 for confirmation that the student is suitable to the specialty of the department. An advisor will
9 be assigned to matriculated students, and the first semester courses shall be approved by the
10 advisor prior to the start of that semester.

11
12 Three letters of recommendation from individuals familiar with the candidate’s academic
13 and/or professional background and capabilities are required. Candidates must also submit a
14 personal statement describing how their academic, professional and personal background has
15 prepared them to be successful in the MSDS program, and explaining how the completion of
16 the MSDS will contribute to their professional goals.

17 ***C. Combined Bachelor and MSDS 4+1 requirements***

18 Students who wish to be admitted to the combined Bachelor/MSDS 4+1 program (details in
19 section III.A.5) should submit an application during the junior year of academic study toward an
20 undergraduate degree at the University of Delaware. Interested students should consult with
21 an advisor from the MSDS program about the courses to be taken in order to fill out the
22 “Graduate Course Approval Form for 4+1 Admission Approval” from OGPE. After submitting
23 that form, the student may then apply to the Bachelor/MSDS 4+1 program. At a minimum, the
24 applicant must have a cumulative GPA of 3.2 and a GPA of 3.4 in their undergraduate major.
25 For any Bachelor degree, the applicant must have completed the background requirements
26 listed in Section II.B by the end of the fourth year of undergraduate study. Two letters of
27 recommendation from University of Delaware faculty and academic transcripts must be
28 submitted. Neither the GRE nor the TOEFL exam is required for 4+1 program applications.

29 ***D. Application deadlines***

30 The application deadline for Fall admission is July 1; the deadline for Spring admission is
31 December 1. Earlier applications are encouraged because space may be limited.

32 ***E. Types of Admission***

33 Students may be admitted into the program in one of two categories as follows.

- 34 1) Regular Admission: Regular status is offered to students who meet all of the
35 established entrance requirements.
- 36 2) Conditional Admission: Successful applicants are typically admitted conditionally
37 because stated information is self-reported and uploaded documents are

1 unofficial. Fulfilling the conditions stated on an offer of conditional admission by
2 the first date of graduate coursework is critical, so the instructions stated on the
3 letter must be followed carefully. Failure to clear all stated conditions by the
4 start of graduate coursework may result in revocation of admission to the
5 graduate program.

- 6 3) Provisional Admission: Provisional status is offered to applicants who are seeking
7 admission to a degree program but lack specific prerequisites needed in the University
8 of Delaware degree requirements. All provisional requirements must be met within the
9 deadline given before regular status can be granted. Failure to meet the provisions by
10 this deadline is grounds for dismissal from the program.

11 ***F. University Statement***

12 Admission to the MSDS graduate program is competitive. Those who meet the stated requirements are
13 not guaranteed admission, nor are those who fail to meet all of those requirements necessarily
14 precluded from admission if they offer appropriate strengths.

15 ***Part III. Academic Degree: Master of Science with a major in Data Science*** 16 ***(MSDS)***

17 ***A. Degree Requirements***

18 A total of 30 credits is required for the degree. If the student lacks background knowledge for
19 one or more courses, prerequisite courses may need to be taken that do not count toward the
20 degree.

21 1) Required Courses

- 22 a) At least six credits of core courses are required from the following list from DMS
23 (each course is three credits):
24 ○ MATH612 Solving Linear Equations and Optimization (F)
25 ○ MATH637 Mathematical Techniques in Data Science (S)
26 ○ MATH672 Vector Spaces (F)
27 ○ MATH630 Probability Theory and Applications (F)
28 b) At least six credits of core courses are required from the following list from CIS (each
29 course is three credits):
30 ○ CISC621 Algorithm Design and Analysis (F/S)
31 ○ CISC637 Database Systems (F/S)
32 ○ CISC683 Introduction to Data Mining (F)
33 ○ CISC684 Introduction to Machine Learning (S)
34 c) At least six credits of core courses are required from the following list from AES
35 (each course is three credits):
36 ○ STAT611 Regression Analysis (F)
37 ○ STAT613 Applied Multivariate Methods (F)

- 1 ○ STAT674 Applied Data Base Management (F/S)
- 2 ○ STAT675 Logistic Regression (S)

3 Credit for both STAT674 and CISC637 cannot be applied to the degree.

4 2) Electives

5 Up to 12 credits of elective courses may come from a variety of courses on campus with
6 relevant application or quantitative content. An initial list of example courses is given in
7 Appendix A. The courses must be at the 600 level or above for the home college from which
8 the degree is awarded. A course from the required lists may be chosen as an elective provided
9 that it has not already been used to satisfy the six core course requirement. The initial elective
10 list is not meant to be exhaustive. The electives taken by the student must be approved by the
11 advisor and the Executive Committee of MSDS. The student's choices of electives shall be
12 approved by the advisor prior to registration and by the executive committee prior to the
13 beginning of the last semester.

14 3) Non-thesis option

15 30 credits of course work are required. Up to three credits of Special Problem or Research can
16 be applied toward the credit total. These Special Problem or Research credits may come from
17 experience on campus or in industry (e.g., internships). Special Problem or Research credits
18 must be related to the degree and must be approved by the advisor and the executive
19 committee. Valid scholarly output from such credits are presentations (oral or poster), papers,
20 reports or similar that demonstrate related work in the field.

21 4) Thesis option

22 Up to six credits can be used to do a MS thesis according the requirements of the department
23 in which the student will take the degree. The University requirements for master's theses shall
24 apply to the thesis in this degree. The committee for the thesis shall include three members
25 with at least one member not from the specialty department.

26 5) Bx/MSDS 4+1 program

27 The MSDS can be obtained in conjunction with a limited numbers of Bachelor degree programs
28 as a 4+1 combination. Here the x in Bx can be A for Arts, S for Science or other letters for other
29 degrees. At the time of writing, the Bachelor degrees available are as follows. Any of the
30 Bachelor degrees from the DMS may be combined with the MSDS: BA in Mathematics or
31 Mathematics Education; BS in Actuarial Sciences, Applied Mathematics, Mathematics and
32 Economics, Mathematics Education, or Quantitative Biology; or honors versions of any of them,
33 HBx. Similarly, any of the Bachelor degrees from CIS, ~~or from~~ Electrical and Computer
34 Engineering (ECE), **Mechanical Engineering (ME)**, or **Physics and Astronomy (DPA)** are available
35 for combining with the MSDS as a 4+1 program. From CIS, these are: Computer Science (BA,
36 BS); Information Systems (BS); and honors versions (HBx). From ECE, these are: Computer

1 Engineering (BCpE); Electrical Engineering (BEE); and honors versions (HBx). From ME, these
2 are: Bachelor of Mechanical Engineering (BME), and the honors version (HBME). From DPA,
3 these are: BS, BA, HBS, HBA options in each of Physics or Astronomy, as well as BA and HBA in
4 Physics Education. Up to six credits from the graduate course work may be applied to the
5 Bachelor degree that come from the area of the undergraduate major. For example,
6 mathematics courses may be applied to a major from DMS, computer science courses can be
7 applied to a major from CIS, and electrical engineering courses may be applied to a major from
8 ECE.

9 Students who wish to be admitted to the Bx/MSDS 4+1 program should submit an application
10 during the junior year of academic study toward an undergraduate degree at the University of
11 Delaware as described in section II.C.

12 6) Advisor and Program of Study

13 An advisor will be assigned prior to the start of the first semester of study for the MSDS. The
14 first semester courses shall be approved by the advisor prior to the start of that semester. The
15 student and the advisor will develop a program of study; the program of study submitted to the
16 executive committee for approval prior to the end of the first semester of courses. For
17 students accepted into the 4+1 program, an advisor for the MSDS will be assigned prior to the
18 end of the second semester of the junior year of undergraduate study, and a program of study
19 for the MSDS shall be approved before the end of that semester.

20 7) Changes to the Program of Study

21 Students may need to alter approved programs of study due to scheduling conflicts or the
22 creation of new courses directly related to the student's goals. Students who wish to make
23 minor changes to their program of study must obtain permission from their advisor. Major
24 changes to the program of study, such as the substitution of one or more core courses, must be
25 approved by the Program Committee. All changes in a previously approved program of study
26 must be approved by the Program Director.

27 8) Transfer credits

28 Up to six credits may be transferred from courses applicable toward the degree, provided that
29 the credits have not been applied to obtain a different degree. The transfer must be approved
30 by the Executive committee, and if necessary, in consultation with the department that offers
31 the (potentially) equivalent course.

32 9) Awarding the degree

33 The student can choose which department, and thus college, awards the MSDS. The primary
34 departments are expected to be DMS, CIS, or AES, but other departments are possible. The
35 department/subject of the degree may be awarded by that college under the following
36 circumstances.

- 1 a) If the student does a thesis, then the department of the advisor may be the department
2 and college of the degree.
- 3 b) If the student does a project course with an advisor, together with at least one other
4 course from that department, then the student may be awarded a degree from that
5 department and college.
- 6 c) If the student does neither a project nor a thesis, then the degree may come from the
7 department (and college) from which the student took at least 4 courses.

8 Exceptions to the above policies may be granted by the executive committee. The executive
9 committee shall approve the subject and any emphasis of the MSDS prior to the student
10 applying for the degree (i.e., the forms submitted prior to graduation).

11 ***B. Timetable and satisfactory progress toward the degree***

12 1) Academic load and satisfactory progress

13 The MSDS program will follow the University of Delaware, Office of Graduate and Professional Education
14 recommended policy for determining students' failure to make satisfactory progress towards degree
15 requirements and time limits for completion. Students may be enrolled on a full-time (9 credits per
16 term) or part-time (fewer than 9 credits per term) basis.

17 2) Grade and GPA requirements

18 Students must pass all of the core courses with a minimum grade of B or better, and a grade
19 point average (GPA) of 3.25 or better in the six core courses, to continue in the program. The
20 student may repeat a core course one time in order to earn an acceptable grade for the degree.
21 All graduate-numbered courses taken with graduate student classification at the University of
22 Delaware are applied to the cumulative GPA. Credit hours and courses for which the grade is
23 below B- do not count toward the degree even though the grade is applied to the overall GPA.
24 Elective courses may not be repeated to apply to the degree.

25 3) Grievance procedures

26 Students concerned that they have received an unfair evaluation or have been graded
27 inappropriately may file grievances in accordance with the student guide to University of
28 Delaware policies. Students are encouraged to contact the program director prior to filing a
29 grievance.

30 **Part IV. Assessment Plan**

31 ***A. Program***

32 The program will follow the Academic Program Review (APR) schedule, policies and procedures,
33 established by the Provost's office and Faculty Senate. Data will be provided by the Office of
34 Institutional Research and Effectiveness, in conjunction with faculty/student interviews,
35 measures of scholarly productivity and alumni. Meetings will be held at least semi-annually to

1 discuss curricular changes, review data, identify actions to strengthen the program, and
 2 establish timelines and assignments for responsibilities. The program will continue consultation
 3 with the Center for Teaching and Assessment of Learning to periodically assess learning
 4 outcomes, assessment criteria, and benchmarks for success.

3 **Part V. Financial Aid**

4 This is a professional master’s program and students are expected to pay graduate tuition.

5 **Part VI. Program organization and administration**

6 It is expected that this program be housed in a department or college office. It will most likely
7 be located in Mathematical Sciences within Ewing Hall.

8 **A. Affiliated Faculty**

9 The affiliated faculty shall include the following: the executive committee; faculty interested in
10 teaching courses for the MSDS program; faculty interested in offering projects and non-
11 academic contacts for projects; faculty who will supervise theses for the degree; and
12 administrators contributing any of the above to the program. The initial executive committee
13 will accept the CV of interested faculty and approve or deny the application for affiliated
14 faculty.

1

2 **B. Director**

3 The Program Director will be elected by the executive committee and affiliated faculty, and may
4 involve an interview process. The Program Director will typically be from one of AES, DMS or
5 CIS, but other departments are possible from within the participating (degree-granting) colleges
6 provided that the candidate has experience with related courses, projects or subject matter.
7 The approval of the Director Elect’s home Department Chair with appropriate course release or
8 other support for the position is required. The Program Director will serve for a three year
9 term. Re-election requires a majority vote of the affiliated faculty that vote; the vote may be
10 electronic. The initial appointment of the Program Director shall be made after an interview
11 process that involves the department chairs of AES, CIS and DMS and the initial affiliated
12 faculty. Those department chairs will make recommendations to the affiliated program faculty.
13 Applications will include a cover letter stating interest in the position and plans for the
14 program, and a complete curriculum vitae.

15

16 The responsibilities of the Program Director include:

- 17 1. Leading and overseeing the program;
- 18 2. Organizing and leading meetings of affiliated faculty and the Program Committee;
- 19 3. Communicating as needed with the Office of Graduate and Professional Education, and
20 other appropriate offices such as Continuing Education;
- 21 4. Serving as first point of contact for issues arising with program students and faculty;
- 22 5. Approving all changes to programs of study;
- 23 6. Approving all changes in faculty advisors.

24 **C. Executive Committee**

25 An executive committee consisting of one member from each of DMS, AES, and CIS (including
26 the director), plus two to four at-large members from other departments.

27 The terms of the Executive Committee members will be staggered with two year terms for half
28 of the committee (excluding the director). An Executive Committee member may serve two
29 consecutive terms with an affirmative vote of the affiliated faculty.

30 Responsibilities of the Executive Committee include:

- 31 1. Making admissions decisions on students for each of Fall, Winter and Spring terms;
- 32 2. Matching students to faculty advisors;
- 33 3. Approving all new programs of study and major changes to existing programs of study,
34 including transfer, special problem or research credits;
- 35 4. Identify contacts for projects and data for both on campus and off campus experiences;
- 36 5. Attend events as required for the program such as for recruiting and making contacts
37 for projects and data;
- 38 6. Approve or deny applications for affiliated faculty.

1 ***D. Steering Committee***

2 A committee of select distinguished faculty as well as non-academic contacts from industry,
3 commerce and government shall be formed to advise the executive committee and all others
4 involved in the management of the program. They will be expected to meet at least annually to
5 discuss and advise the program.

6 **Part VII. Appendices**

7 ***A. Elective Courses***

8 The design of this degree is flexible. Courses appropriate from the main departments, as well
9 as a few others, are listed below as a sample. The list is not meant to be exhaustive. The
10 electives taken by the student must be approved by the advisor and the Executive Committee
11 of MSDS.
